PROPOSED ADOPTION OF THE AMENDED AND RESTATED BYE-LAWS

This announcement is made by KADER HOLDINGS COMPANY LIMITED (the “**Company**”) pursuant to Rule 13.51(1) of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”).

The board (the “**Board**”) of directors of the Company proposes that certain amendments (the “**Proposed Amendments**”) be made to the existing bye-laws of the Company (the “**Bye-Laws**”) by way of adoption of the amended and restated bye-laws (the “**Amended and Restated Bye-Laws**”) in substitution for and to the exclusion of the Bye-Laws, for the purposes of, among other things, (i) bringing the Bye-Laws in alignment with the Core Shareholder Protection Standards set out in Appendix 3 of the Listing Rules; and (ii) making other consequential and housekeeping changes.

The Proposed Amendments and the adoption of the Amended and Restated Bye-Laws are subject to the approval of the shareholders of the Company (the “**Shareholders**”) by way of a special resolution at the forthcoming annual general meeting (the “**AGM**”) of the Company to be convened and will become effective upon the approval by the Shareholders at the AGM.

A circular containing, among other things, further details of the Proposed Amendments and a notice convening the AGM will be dispatched to the Shareholders in due course.
